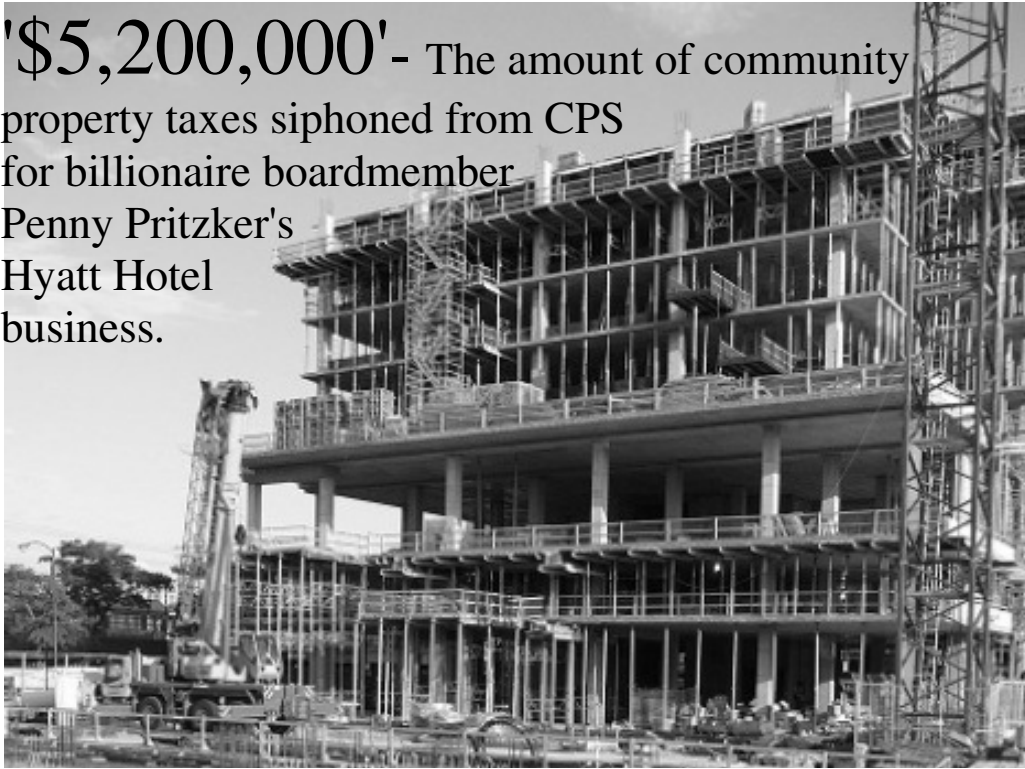


'\$5,200,000' - The amount of community property taxes siphoned from CPS for billionaire boardmember Penny Pritzker's Hyatt Hotel business.



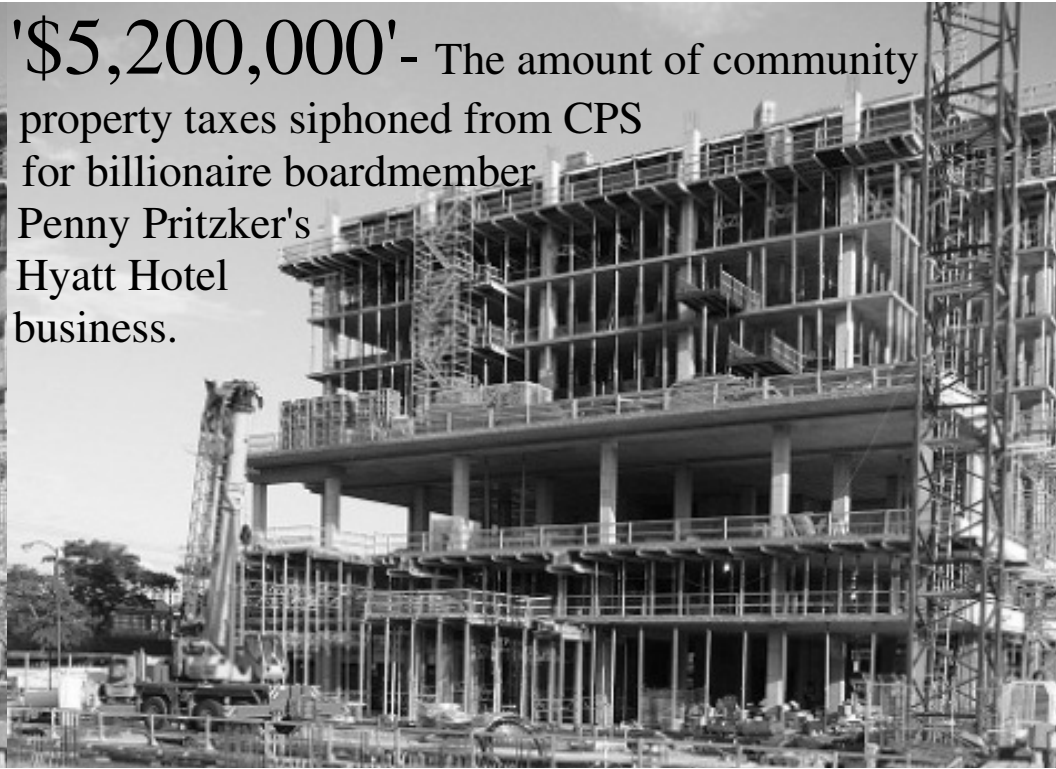

As a member of the Board of Ed, it's Penny's job to find money for our schools, not to take our money for her business. TIFs are property taxes the mayor controls valued at \$500 million a year. By state law, 62% of that would go to public schools, over \$250 million this year. But the unelected board appointed by the mayor has no incentive to go against him as he squanders the public's funds on political favors.

**7 schools from this neighborhood are scheduled to be defunded in the Boards' CPS 2013 budget by \$3,379,677, close to %62 of \$5,200,000.**

We must end the chronic defunding of neighborhood schools by reclaiming TIFs and taxing the rich. It's our money, our kids, our teachers, our communities and our schools—we should have most of the say in how it's run, not out of state special interest groups backed by the 1%. The Chicago Board of Education must be elected and representative of the CPS community.
